- 2) REVIEW AND APPROVAL OF CONSTRUCTION CONTRACT: Whitfield Educational Center Administrative Building, per the District's Request for Proposal of Phase II construction of its administration building, which closed on August 18th, 2022, the Board reviewed draft Resolution #3-2023 regarding the District approving the construction contract award to Anissa Construction, contingent on the District obtaining a loan with the New Mexico Financing Authority through its Public Project Revolving Fund Program for the balance of funds required to construct the District's Whitfield Educational Center's Administrative Office Building. Treasurer Moya moved to approve Resolution #3-2023. Vice

Chair Smith de Cherif seconded the motion. A roll call vote was conducted: Smith de
Cherif—yes; Moya—yes; Bonine—yes; Goodman—no; Draszkiewicz—yes; Camarena—
